Short Film Trainer:	<ul> <li>Review and finalize story ideas proposed by elevate project participants.</li> <li>Conduct two training sessions for 50 female undergraduates on producing short films advocating SRHR.</li> <li>Provide inputs for pre-and post-workshop evaluation questionnaires.</li> <li>Deliverable: Session plan and a one-page report on overall workshop progress.</li> </ul>
